What is the book about?

The abortion debate in the United States is very confused. Ratings-driven media coverage highlights extreme views and creates the illusion that we're stuck in a hopeless stalemate. Camosy argues that our polarized public discourse hides the fact that most *Americans actually agree on the basic issues at stake in abortion morality and law.* First unpacking the real complexity of the abortion issue, he shows that placing oneself on either side of the typical polarizations — pro-life vs. pro-choice, liberal vs. conservative, Democrat vs. Republican — only serves to further confuse the debate and limits our ability to have fruitful dialogue. Finally, Camosy proposes a new public policy that is consistent with the beliefs of the broad majority of Americans and supported by the best ideas and arguments about abortion from both secular and religious sources.

How is it any different than other books on the issue?

- Acknowledges where those on both sides are correct
- A pro-life book, but one that refuses to dismiss pro-choice reasoning, opting instead to integrate the concerns of pro-choice advocates
- Proposes a new public policy -- the Mother and Prenatal Child Protection Act (MPCPA) -- that is consistent with the beliefs of the broad majority of Americans and supported by the best ideas and arguments about abortion from both secular and religious sources
- Doesn't just rehash/summarize/demonize
- Not written along party lines, but instead focuses on the bizarre ways in which both major political parties actually betray their most fundamental values on the abortion issue
- Tackles RU-486 the abortion pill
- Thoroughly researched and well-argued, but also highly-accessible, practical
- More than just another theoretical analysis

- Has someone FINALLY presented a way forward, through this divisive and ugly debate?
